# **Privacy Statement – Internet**

This privacy statement is related to the information we collect from you when you buy one or more of our products through our website. By collecting this information, we act as data controllers and we are obliged by law to provide you with the relevant information regarding us, the reason and the way we use your data, as well as the rights you have upon the latter.

#### Private data

Pursuant to the General Data Protection Act of the EU, personal data is defined in the following way:

"any information related to a recognized or identifiable natural person (data subject). An identifiable person is someone that can be identified directly or indirectly by reference to an identifier such as a name, an identification number, location data, an internet identifier, or one or more factors related to the physical, physiological, genetic, intellectual, cultural or social identity of that natural person ".

#### Who are we?

The company "Aggelos Kandylis & Co. Ltd" aims to exploit, to operate, to lease and to manage all types of furnished apartments.

## What personal data do we collect?

When you browse on our website, we automatically collect certain information using cookies (such as IP preference information, device usage information) that is, information that allows us to remember you and your preferences when using this website. We use cookies to collect information of this kind, such as your IP address, which we use to record your interest and visits in our site.

## How do we use your information?

This privacy notice indicates how we, the Company "Aggelos Kandylis & Co. Ltd.", will collect and use your personal data to provide you with our services, to maintain contact with you and to handle requests or complaints submitted to us in order to optimize our services for the purposes of (direct) promotion and market research.

The Company "Aggelos Kandilis & Co. Ltd" will process (collect, store and use) the information you provide in a way compatible with the EU's General Personal Data Protection Policy (GCPPD). We will try to keep your information accurate and up-to-date and not keep it for longer than necessary. How long certain types of personal data should be retained may also be governed by specific business requirements and agreed practices.

# Why do we collect this information?

In order to advance on our website and provide you with our services, we need to collect personal data. In any case, we are committed to ensuring that the information we collect and use is appropriate for that purpose and does not resulting in violating your privacy.

The information collected through cookies allows us to remember you and your preferences when using this website in order to provide you with a better browsing experience as well as higher quality services. In particular, by Google Analytics we can use this data to determine the number of people using our website in order to better understand how they find and use our website as well as to watch their progress on the website. Although Google records data, such as your geographic location, your device, your web browser and your operating system, none of this information makes you personally familiar to us.

# Are you going to share my data with someone else?

We may share your personal data with third party service providers associated with our website and / or the company during our cooperation. Any third parties with which we share your personal data are required to safely keep your information only for legal purposes. The Company "Aggelos Kandylis & Co. Ltd." does not process and transfer your delicate personal data to any third parties without your explicit consent unless there is another legal reason for processing or obligation. Your information is stored in the editing system of the hosting provider of our website and other providers of online services such as Google, whose headquarters is located in the US and is certified in the EU-US Privacy Safety by providing adequate protection measures.

The Company "Aggelos Kandylis & Co Ltd" does not use the information you provide us to take any automated decision that may affect you.

## How long do we keep your information?

We usually keep your browsing information anonymous and for the period of time that you stay on our website. However, it is likely that your data will be kept for 2 years, maximum. In case you send us a request, the period of time where we shall keep your information provided by yourselves (e.g. contact details) varies, depending on the time that your request is answered.

# Your rights upon your information

Our company can confirm what type of information we possess about you and how it is processed upon your request. If the Company possesses your personal data, you can request the following information:

- Identity and contact details of the controller who has decided how and why your data will be processed.
- The purpose of processing and the legal basis of the latter.
- If processing is based on the legal interests of our company or any third party, you can request information about these interests.
- The categories of personal data collected, stored and edited.
- The recipient or categories of recipients to whom the data was / will be made available.

- If and provided that we transfer personal data to a third country or international organization, you can request information on how to ensure that this is safely carried out. The EU has approved sending personal data in some countries because they possess a minimum level of data protection. In other cases, we ensure that there are special measures to safeguard your information.
- The period of time that your data will be stored.
- Details about your rights to correct, delete, limit or oppose some edits.
- Information about your right to withdraw your consent at any time.
- How to submit a complaint to the supervisor.
- If the provision of personal data is a legal or contractual requirement, and if you are required to provide personal data as well as the consequences of a possible failure to provide such data.
- The source of personal data in case it was not collected directly from you.
- Any details and information of automated decision making, such as profile creation and the significance and expected consequences of such processing (if any).
